Subject: Invitation to attend the EU Rules on Nutrition and Health Claims and the New EU Regulation on Food for Specific Groups

To whom it may concern

On 19 June 2017, the Delegation of the European Union to Thailand and Food and Food and Drug Administration will organise a Public Seminar on "EU Rules on Nutrition and Health Claims and the New EU Regulation on Food for Specific Groups", with high-level speakers from Thailand, the European Union. The Public Seminar will be funded through the Public Diplomacy and Outreach programme PDO of the European Union.

The purpose of the Conference is to contribute the common understanding on the EU relegation on Food for the Specific Groups such as food intended for infants and young children, food for special medical purposes and total diet replacement for weight control. It aims to protect specific vulnerable group of consumers, also to increase legal clarity for business and to facilitate correct application of the rules. We will have expertise from European Union and expert from Public sectors, in line with the principles behind the Nutrition/Health Claims and Food for Specific Groups.

The programme will support the subsistence costs of 160 participants from the private sector and from the national authorities and or institutions involved in the development and application of the national action plans and containment programs. We will welcome representatives from the Thailand Ministry of Public Health, academia, actively working on tackling this pressing issue within "Nutrition/Health Claims and Food for Specific Groups approach."
